AGAIN THIS YEAR WE ARE LOOKING FOR PEOPLE TO HELP SPONSOR THE BIKE DRAWING.



## **MAINE FARM DAYS RULES AND REGULATIONS EXHIBITORS AGREE**

1. To provide proof of liability insurance coverage for any day's exhibitors will be on the site setting up, exhibiting, or taking down an exhibit.
  2. To be fully responsible for completely setting up and disassembling individual displays.
  3. To be completely set up by 9:00 a.m. on Wednesday, [August 23 2017](#) and to not take down the exhibit until after 4:00 p.m. on Thursday, [August 24, 2017](#).
  4. To make arrangement for their own tables, chairs and other equipment.
  5. Not to distribute any dangerous or harmful articles.
  6. To provide adequate safety guards or shields for moving equipment or parts, to observe proper safety standards when operating equipment, and to take other precautions as needed to prevent injury to all persons on the grounds, including the prohibiting of any person from riding on farm equipment in an unapproved or unsafe manner.
  7. To remove all rubbish, refuse boxes, and any type of materials used in the display from the site no later than Thursday, [August 24, 2017](#) by 6:00 p.m. (anything left after 6:00 p.m. will be vendor's responsibility).
  8. That no refund for contracted space will be made unless notification of cancellation is received by the Treasurer twenty-one (21) days in advance of the date of Maine Farm Days (i.e. [August 1, 2017](#)).
  9. That if an exhibitor in a tent or field area, to pay for any additional space used beyond that paid in advance prior to setting up.
  10. That if a food vendor, to pay 10% of NET sales to Maine Farm Days prior to [Sept 1, 2017](#).
  11. To be responsible for damage to or loss of any tents, tables, chairs, or other items rented to you for your exclusive use during Maine Farm Days.
